### **SR.ENGINEER (MECHANICAL) :**

Minimum 4 years of experience in areas such as HVAC design and execution of HVAC Projects and expertise in handling & executing large HVAC Projects like installation of A/C chillers, AHU's, Pumps, Erection of ducts, Chilled/Hot water pipe lines, Including estimation and Measurements. Also exposure to execution of Fire Alarm Systems, Integrated Building Management Systems, VRV A/C Systems, Split A/C's, Fire Hydrant Systems etc. Exposure to AutoCAD & Microsoft project is desirable.

## **METHOD OF SELECTION:**

Selection will be through a Written Test followed by an Interview (only for those candidates who will be shortlisted based on their performance in the written test).

### **HOW TO APPLY:**

Candidates willing to apply may submit their application in the prescribed format along with the copies of the relevant documents in support of eligibility and the Application fee payment receipt/Challan with the Journal Number, in a sealed cover super scribing “Application for the post of Dy.
