Requirements: 07 posts for all over India. These vacancies are for civil construction, site installation and commissioning, etc of BEL Equipments/ Systems. The tentative Sites are –

- Any other BEL sites, BEL units/Regional Offices/any other work Area of BEL/Regional Service Centers (RSCs)/ anywhere in India as decided by BEL.

Posting of Engineers at any location in India is the sole discretion of BEL Management. BEL also reserves the rights of posting of any Engineer anywhere on rotational basis in due course of service. Decision on place of initial posting and thereafter rotation of Engineer will be decided by BEL on requirement basis and No request of any type will be entrained in this regard.

Qualification: First class for General and OBC Candidates and Pass Class for SC/ST candidates in BE / B.Tech from a recognized University/ Institution. Only the following disciplines are allowed –

- i. Civil Engineering

Age: Maximum age limit as on 01.09.2017 is 28 years for General; 31 years for OBC and 33 years for SC/ST candidates respectively.

Reservation for 7 posts: Gen – 06, SC - 01

Remuneration: An all-inclusive consolidated remuneration of Rs.23,000 per month for those possessing experience 0 to 1 year, Rs.25,000 per month for those possessing experience between 1-2 years and Rs.27,000 per month for those having more than 2 years of experience. However, the decision of management i.r.o remuneration will be final and binding.

Period of contract: One year from the date of joining, however the same may be extended depending on the progress of the project and performance of the candidate.

Job Requirement: Follow up of project management activities, customer interaction, Field services, work related to civil and infrastructure construction at customer sites.

Desirable Experience: Experience in Project Planning. Site coordination, estimation, execution of Industrial infrastructure and underground complexes, continuous casting of RCC slabs, SOIL/ROCK stabilization during excavation, Quality Control Procedure, co-ordination of Inter-disciplinary activities, billing, exposure to AutoCAD and Microsoft Project will be preferred.
